

3. The school shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and directions/instructions issued by Department from time to time.
4. School shall appoint new Principal as per RRs/guidelines of DOE.
5. The school shall pay full allowances & all benefits to its staff as per section 10 (1) of DSEAR, 1973 and submit compliance report in District office within one month time.
6. School shall comply with clause 14 of order No. F.DE/15 (56)/Act/2009/778 dated 11/2/2009 in r/o maintenance of DRF. School shall also ensure to follow GN-21 'Accounting by schools' as issued by the Institute of Chartered Accounting by schools' as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.


