Rules & Regulation of "RAHUL EDUCATIONAL SOCIETY"

1. Name : The name of the Society shall be "RAHUL EDUCATIONAL SOCIETY"
2. Membership : Subject to the approval of the Governing body. Any male or female adult of any caste or creed, working or non-working, and essential a resident of the Union Territory of Delhi may become the member of the society provided he/she believes in the aims and objectives of the society.
3. Subscription : The rate of subscription for all the members shall be Rs. 8/- per month besides any amount of donation or gift to the association of his/her own free will.
4. Refusal or expulsion : The governing body of the society may refuse any person for the membership provided reasons for refusal shall be communicated to the person concerned.



The governing body of the society may expell any member from the society on the following grounds :

1. If the member fails to pay the monthly contribution/subscription continuously for three times.

If the member works against the aims and objectives of the society.

If the member tenders his/her resignation.

If the member fails to attend three meetings of general body and governing body.

The reasons for expulsion shall be communicated to every members. Every such expelled member shall have a right to appeal before the General Body which may or may not be accepted.

5. General Body : There shall be general body of the association consisting of all the members. The meeting of the general body shall be held after every one year with 1/3 quorum by giving 14 days notice. No quorum shall be required in the adjourned meetings. An emergent meeting of the body may also be summoned on the written request of 3/5 members. Following business shall be transacted in these meetings :



- To prepare annual programme and policies.
- To pass the annual budget of the association.
- To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the association.

6. Governing Body : There shall be a governing body of the association to look after and to manage the day to day affairs of the association. It shall consist of minimum 12 and maximum 17 members including the office bearers. The meetings of the governing body shall be held after every three months with 1/3 quorum by giving 10 days notice.

No quorum shall be required in the adjourned meetings. An emergent meeting of the governing body may also be summoned on the written request of 3/5 members. Following business shall be transacted in these meetings :

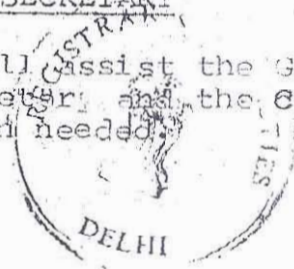
